- A Cargo Gate In Pass should be duly approved by Customs and submitted in advance for Cargo entry and receipt at the CFS
- B Empty Pick up Letter from shipping Line should be submitted at least 48 Hours of the Pick up date with reasonable validity
- C Stuffing request should be submitted at least 24 hours prior planning of the activity at the CFS
- D Cargo Despatch notice to be given at least 36 Hours prior expected arrival at the CFS for proper planning at the CFS for receipt
- E Laden Movement intimation to be given basis planned vessel and cut of at least 24 hours by the shipper / shipper agent
- F Stuffing should be planned to be completed latest by 1800 Hrs for the same day movement to the port
- G All Payments to be effected by 1800 Hrs on Weekdays and 1600 Hrs on Saturdays to arrange smooth operation and movement
- H Trailers carrying Laden containers to be released within 3 hours of the containers reaching the port gate and further shall attract trailer detention
- I Open Top & Flat Rack Containers with ODC cargo shall be charged twice times the Normal Handling & Transportation Charges as per container size
- J In case of HAZ-1 Cargo, rate will be 1.25 times higher than the normal of Handling & Transportation Charges.
